2. **MINUTES**

4. **CHAIRMAN'S REPORT**

5. **ACCOUNTS 2008/09**

The Clerk presented the final budget figures for 2008/09, which did not include a bank reconciliation, owing to the early date of the Annual Parish Meeting. 6. **DISTRICT & COUNTY COUNCIL REPORTS**

Councillor Mrs Kirkbride presented her report on the activities of the County Council. It is hoped that the change of contractor will improve the quality of road

- c) **Pensioners Gift Scheme** – Mrs Bignell, as Treasurer ran through the number of vouchers issued and gifts taken to those in homes or hospital. Mrs Judith Piper has agreed to become the new Chairman.
- d) **Millennium Green Trust** - Mrs Cockrill as Secretary to the Trustees gave a brief update on work to the green in the previous 12 months, which included the provision of post and netting compost bins, which were put together by Mr Trevor Brown. The path and wooden edgings have been repaired. Some seedling trees which had grown too large had been removed. It has been decided to reduce the number of wild flower beds from 3 to 1 or 2 smaller beds, to enable the area to be maintained more easily. Mrs Bignell, as Treasurer, presented the accounts for the financial year ending 31/03/09.
